## What this license encompasses

This End User License Agreement (EULA, "license," "agreement") is a legal agreement between you and the High Alpine Serifs typeface & font designer Sarah Bell and is a binding contract between you and Sarah Bell. This EULA governs the terms of use of the High Alpine Font Software and the design of the Fonts embodied therein, including any use of the Fonts associated with the product now or in the future. This Agreement becomes effective when you (a) click to download the font (b) if you are acquiring this font in a digital format of any kind.

Any violation of the EULA will result in a termination of this license. The font designer reserves the right to change the terms of this EULA at any time.

## Some Terms

Throughout this license "type" and "font" are interchangeably used. Throughout this document the terms "High Alpine Serif" and "High Alpine" both refer to the High Alpine font that the user downloaded with this agreement. The terms "Personal" and "Private" are used interchangeably throughout this document.

## Usage

This agreement pertains only to the single personal use license holder (you). Under this agreement, the licensee (you) may use High Alpine for private non-commercial use only.

Important. Under no circumstances may the High Alpine Serif font (Font Software) be distributed for commercial purposes, profit or otherwise.

Important. Under no circumstances may changes be made to the Font Software without expressed legal consent from Sarah Bell.

1. Upon downloading any High Alpine Serif font (the Fonts), you will be granted a non-exclusive License to use the Font Software that accompanies this private use EULA. The creator of the Font reserves the right to terminate this license agreement at any time, and by accepting this EULA, you agree to this terminable license. Use of the Font Software is limited to the Users who agree to this license. For the purposes of the License, all references to the Fonts in this agreement shall be defined as all aspects of the design of the Fonts. The Font

Software shall be deemed to include any future upgrades including design updates and agreement updates.

2. This legal agreement applies to personal private use only.

3. You do not need to credit the font designer when using this font.

4. A [commercial license](#) for this font must be purchased if the font is displayed on websites that receive over 100,000 views per month.

5. Although under this private EULA, the High Alpine Serif fonts (the Fonts) are free for private use, under this Agreement, the Fonts are considered a Commercial Product.

6. By accepting this Agreement, you agree that the design of the Font and the Font Software and that the unauthorized use of the design of the Font or the Font Software is an infringement of the font designer.

7. The Font Designer, Sarah Bell, retains exclusive rights for the Font. You may not alter Font Software in any manner whatsoever.

8. If you share this font, you agree to include a copy of this Agreement with the person whom you shared the font.

9. If the font is shared without this EULA, the license is terminated for the sharer and recipient of this font.

10. If the High Alpine font was obtained in a way that violates any of the High Alpine End User License Agreements, the license is terminated.

11. The design of the Font, the Font Software and any trademarks associated with the Font Software are the exclusive property of Sarah Bell and are protected by the copyright and other intellectual property law of the United States.

12. You acknowledge that you have read this agreement and understand it and that by using the software you will be bound by its terms and conditions.

13. Sarah Bell expressly reserves the right to amend or modify or terminate this License Agreement at any time and without obligation of prior notification.

14. You agree to be responsible for compliance with all laws, foreign and domestic relating to the control of exports or the transfer of technology.
